Effective March 12<sup>th</sup>, 2020, out of an abundance of caution for the health and safety of people served, families, volunteers, athletes, coaches and our staff, all sport-related activities and other programming involving large group activities and athletes have been canceled. The Opportunity Center is taking precautions based on the directives from the Special Olympics Ohio, the World Health Organization, Governor Mike DeWine, the Ohio Department of Health, and the Ohio Department of Developmental Disabilities, along with the Seneca County Department of Health.

**This is an evolving situation and updates will be provided when we receive more information.**

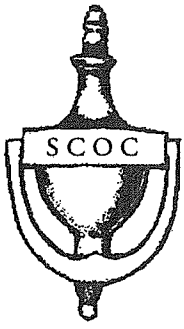
